# FREE KINDERGARTEN FEES

## **Purpose**



This policy will provide clear guidelines for:

- free kindergarten funding for funded sessional kindergarten programs
- reduced fees for children enrolled in a funded kindergarten program in a long day care centre
- the application of surplus funding within Middle Park Kindergarten ensuring it is only used to ensure the quality of program delivery and development of children enrolled in the service
- the setting, payment and collection of (additional hours fees, or long day-care parent fees minus the Free Kindergarten Funding).



## **POLICY STATEMENT**

## **VALUES**

Middle Park Kindergarten is committed to:

- supporting the Victorian Government's Free Kindergarten initiative to be reviewed annually
- increasing access to quality kindergarten programs for all Victorian children
- ensuring there are no financial barriers for families wishing to access an early childhood program for their child/children
- maintaining confidentiality in relation to the financial circumstances of parents/guardians.

## **SCOPE**

This policy applies to the approved provider, persons with management or control, nominated supervisor, persons in day-to-day charge, early childhood teachers, educators, staff, parents/guardians attending Middle Park Kindergarten.

## **BACKGROUND AND LEGISLATION**



#### **BACKGROUND**

The Best Start, Best Life reform will help all Victorian children dream even bigger through increased access to quality early childhood education and care. A critical part of the reform is Free Kindergarten, which will support access to two years of high-quality kindergarten programs for all Victorian children. All families with a child enrolled in a funded kindergarten program are eligible for Free Kindergarten, this includes both 3 and 4-year-old kindergarten programs.

Free Kindergarten supports families to access a funded kindergarten program by:

- providing a free 15-hour program to four-year-old children enrolled at a sessional service
- providing a free 5-to-15-hour program to three-year-old children enrolled at a sessional service (subject to the length of funded program offered)
- offsetting the funded kindergarten program component of parent fees for three and four-year-old children enrolled at a long day care service

Free kindergarten supports every Victorian child to get the best start in life no matter where they live. Research shows that play-based learning is a powerful way to support children's learning and development. Two years of early learning is a crucial part of their educational journey, these benefits last into the school years and beyond.

Regulation 168(2) (n) of the Education and Care Services National Regulations 2011 requires that funded services have a comprehensive written fees policy, and the content of this policy must be communicated to families. Any voluntary parent donations and/or fundraising must comply with the Free Kindergarten subsidy guidelines and be responsive to the local community.

#### **DEFINITIONS**

The terms defined in this section relate specifically to this policy. For regularly used terms e.g. Approved provider, Nominated supervisor, Notifiable complaints, Serious incidents, Duty of care, etc. refer to the Definitions file of the PolicyWorks catalogue.

Approved child care: Approved child care services are services that have Australian Government approval to receive the Child Care Subsidy *(refer to Definitions)* on behalf of eligible parents. Approved child care includes centre-based day care, including long day care and occasional care, family day care, outside school hours care and in-home care.

Child care subsidy (CCS): A Commonwealth Government means tested subsidy to assist eligible families with the cost of child care. Payments are paid directly to approved child care providers. Early Start Kindergarten: A funding program that enables three-year-old Aboriginal and Torres Strait Islander children, and children known to Child Protection to attend a kindergarten program that is planned and delivered by an early childhood teacher for up to 15 hours per week. Details are available at: <a href="www.education.vic.gov.au">www.education.vic.gov.au</a>. Children that are eligible for Early Start Kindergarten (ESK) will continue to be enrolled, this ensure that service providers receive all funding entitlements and that these children have access to 15 funded hours of kindergarten across Victoria. ESK enrolments contribute to School Readiness Funding (SRF) calculations for service providers. It also allows the Department to continue to monitor efforts to engage the most vulnerable children in kindergarten across Victoria and provide additional targeted support where required through SRF or Early Childhood LOOKOUT.

Waitlist fee: A fee for when families register their child directly with a service (not part the councils central enrolment scheme). This fee will not be refunded as it is not part of the Free Kindergarten subsidy, and not related to the fee charged for delivery of the kindergarten program.

Excursion/service event charge: An additional charge required to meet the cost of special events or excursions that occur in response to emerging children's program needs. Events that are planned ahead and are included as an expenditure item in the service's budget do not incur this additional charge (refer to Excursions and Service Events Policy)

Fees: A charge for program hours over and above the 15 funded hours per week (600 per year) and/or wrap around care.

Free Kindergarten: A Victorian Government initiative providing free kindergarten programs for four-year-old and three-year-old children in funded services

Enrolment deposit: A charge to secure a place that has been offered in a program at the service. This should not act as a barrier to enrolling for any families. Services must ensure that families understand that the enrolment deposits will only be refunded if the child commences in the service.

Voluntary parent/guardian payment/donation: A voluntary payment/donation for items not directly related to the provision of the children's program. Explicit and written agreement from a parent is required for any voluntary payments. Attendance at the service is not conditional on this payment.

Wrap around care: care that is provided by a kindergarten service to kindergarten children outside of the 15 hours per week program.

# ATTACHMENT 1. 2023 THREE YEAR OLD FREE KINDERGARTEN INFORMATION FOR FAMILIES

## Important information regarding your child's Free Kindergarten Program for 2023

From 2023, the Victorian Government is offering kindergartens to opt-in to Free Kinder, an initiative that provides up to \$2,500 in additional funding per child.

The Middle Park Kindergarten Committee has decided to opt into this initiative for 2023, with the decision to be a part of the Free Kinder program to be reviewed on a year-to-year basis.

In line with the Victorian Government's requirements for Free Kinder, your child can access an 11 hour kindergarten program at **Middle Park Kindergarten for free** (assuming that you are not doing so at another centre already).

Under the Free Kinder program we will still charge parents for costs associated with one-off special events such as excursions (e.g. to the Kew traffic school) or one off incursions (reptile encounters, concerts etc). Children with concession cards or eligibility categories for KFS will not be charged for this. Our kindergarten will be signing up each family to Ezidebit for collection of these fees.

The Free Kinder funds do not cover weekly sports and music programs offered by specialised teachers, nor do they cover general maintenance of kindergarten facilities. As you know, our Kindergarten is run by a volunteer parent committee and has a history of running a wonderful music and sports program with specialised teachers. To be able to continue our sports and music program, and to maintain the kindergarten in its current state (all of which has thus far been funded through kinder fees), we will be relying on donations (the suggested minimum donation amounts to allow us to continue running those programs are included in the attachment) and involvement from parents.

Please complete, sign and return the attachment by 30 November 2022 to acknowledge that your child is accessing their Middle Park Kindergarten Three-Year-Old 'Free Kinder Payment' at our service in 2023. Please note your child can only receive Free Kinder at one service at any one time and only one year in a Three-Year-Old Kindergarten program.

If your child will be attending another service that offers a Victorian Government funded kindergarten program, including at a long day care service, you must advise that service that you are receiving a funded kindergarten place at our service.

From 2023, the Victorian Government is offering kindergartens to opt-in to Free Kinder, an initiative that provides up to \$2,500 in additional funding per child.

The Middle Park Kindergarten Committee has decided to opt into this initiative for 2023, with the decision to be a part of the Free Kinder program to be reviewed on a year-to-year basis.
